
Goodrich History

The Goodricke, Goodryke) family was originally of the county of Somerset, and from there moved into Lincolnshire, upon the marriage of Henry Goodricke, esq. third son of Robert Goodricke, esq. of Nortingley, with a Lincolnshire heiress, Miss Strickford.

In Lincolnshire the Goodrickes flourished for six subsequent generations, until Henry Goodricke, esq. (third and youngest son of William Goodricke, esq. and Jane Williamson—brother of Thomas Goodricke (1494–1554), Lord Bishop of Ely, and Lord Chancellor of England of [Edward VI—purchased Ribston and other estates, in Yorkshire, from Charles Brandon, Duke of Suffolk in 1542. By letters patent, dated August 28th, 1545, King Henry VIII granted to him the Manor and Rectory Church of Hunsingore, Co. York, with their rights.



The will of Henry was proved by his eldest surviving son Richard. It is a very long document, and deals exhaustively with the whole of his estate. After bequeathing several legacies and annuities to his servants and relatives in addition to his sons William, Richard, Christopher, and John his sister Fulnetby, his daughter Alborough and her husband Christopher Langholme, and his nephews Lionel and Thomas Goodrick Henry appointed his brother Thomas (Bishop of Ely) supervisor of his will in the following words:

" I will that my burial black Coats and gowns be given to all my old servants before rehearsed and to other my waiting servants as my Executors shall think me true and convenient with that advice of my lord of Ely whom I ordain and make the supervisor of this my testament and last will charging and commanding all my children to be ruled and ordered by his advice and council. And I beseech his Lordship as one brother may do for an other to be good lord unto them."

Bishop Goodryke however pre-deceased him. William, the eldest son, died in his father's lifetime, and Richard Goodrick, the second son, therefore proved this will, and succeeded to the Ribston estate (1556). Christopher, the third son, who should have succeeded to his father's lands at Kippax and

Wisbech, died without issue, and was dead in 1563\4, so that this property fell to John the fourth son, who resided at Dodington, and married Margaret Eston.

Henry Goodricke married Margaret, daughter and co-heiress of Sir Christopher Lawson, knt. of London, and dying in 1556, was succeeded, by his eldest son and ANCESTOR Richard Goodricke, esq. of Ribstone, in Yorkshire, who was born, 1524. He was high-sheriff of Yorkshire in 1579, and died 1581. He married Clare, daughter of Richard Norton, of Norton-Comers, in Yorkshire Esq; and was succeeded by his eldest son Richard Goodricke, esq. who was born in 1560 was also high-sheriff of Yorkshire in 1591. He married Meriol, daughter of William, Lord Eure, and dying in 1601, who was succeeded by his eldest son Sir John Goodricke, knt. who married Jane, daughter of Sir John Saville, of Methley, in Yorkshire, knt. was succeeded by his son John Goodricke the 1st baronet. There were twelve children by this marriage, of which were three daughters, Jane, and Elizabeth, who died unmarried, and Mary, married to Richard Hawksworth, of Hawksworth, in Yorkshire. Esq; and nine sons, but only three survived their father, viz. Sir John, his eldest, at his death. 2. Savile Goodricke, Esq; who died at Vienna, aged 32; and, 3. Sir Francis, who married Hester, the daughter of Peter Warburton, of the Grange, in Cheshire, Esq; but died without issue, in August 1674, at Durham, where he was chancellor.

After Ribston in Yorkshire the ancestor Goodrichs lived for about three generations around Hessett, Suffolk, England. Before 1636 William Ephrem Goodrich immigrated briefly to Waterton, Massachusetts before settling in Wethersfield, Hartford, Connecticut. The Goodrichs lived there (and nearby Glastonbury and Rocky Hill) for five generations. They finally settled in Owego, Tioga, New York and in nearby Binghamton. Some Goodrichs still live in the area. Owego is a village in and the county seat of Tioga County, New York, United States. The population was 3,896 at the 2010 census. It is part of the Binghamton Metropolitan Statistical Area. The name is derived from the Iroquois word Ahwaga, meaning where the valley widens. The Village of Owego is by the west town line of the Town of Owego and is west of Binghamton, New York. Owego is one of only twelve villages in New York still incorporated under a charter; all other New York villages have incorporated or reincorporated under the provisions of Village Law.

David L Goodrich, son of Erastus Goodrich and Hope Talcott was born on 03 Jan 1813 in Owego, Tioga, New York. He died on 08 Jul 1896 in Owego, Tioga, New York. He married Frances A. Truman, daughter of Aaron Benjamin Truman and Experience Park on 13 Jul 1841. David is his own fourth cousin with two branches to William Ephrem Goodrich and Sarah Marvin.

Frances A Truman, called Fanny, daughter of Aaron Benjamin Truman and Experience Park was born on 01 Apr 1818 in Owego, Tioga, New York. She died in 1894 in Owego, Tioga, New York. David and Frances are distant cousins Pwith common ancestors William Goodrich and Margaret Richardson.

David Goodrich began work when eight years old as a farmer's boy, but before he was fifteen he had taught school three months. In 1830 he began working for John Hollenback, an Owego merchant, and in two years had saved \$140. He then went on the river and for years run arks, rafts and lumber to market, doing a successful business. He then went to work for Lyman Truman and Brothers and afterward became active with the firm in their extensive operations. He and George Truman engaged in the dry goods business, and in July, 1841, he married Mrs. Truman's sister, Frances A. Truman. From 1861 to 1872 he was in the mercantile business with various partners. Later he engaged in farming. Mr. Goodrich died in Owego, July 3, 1896. In business life, he was an earnest, honest and capable man, therefore he was successful.

Obituary. David Goodrich was born in what was known as the Goodrich settlement in the town of Tioga, where his father, with others from Endfield in the Connecticut valley, had settled while Tioga and much of the surrounding county was unbroken wilderness. When a young man he became engaged in rafting lumber down the river, selling it at the great lumber market at the mouth of the Susquehanna river. He also engaged in mercantile business and until about 1870, when he retired from active life. He was among the best known and most highly respected of Owego's businessmen. A charter member of the Congregational church in Owego he was one of the staunchest supporters and a most ardent advocate of its principles and policy. An uncompromising Republican and Unionist his sympathies took material form and more than one family whose bread winners were defending the nation's honor in the sixties, had their burdens lightened by the kindness of "Uncle David." After the battle of Gettysburg, he was one of the number from Owego to minister personally to the wounded on the battlefield. A sturdy soldier and defender of the right has fallen. The clear, strong voice of duty rings down the line, "Close up the ranks," let us who still are privileged to hold our places hear and obey until we, too, having fought a good fight and kept the faith, shall find our victors crown. Mr. Goodrich is survived by two sons, Charles T. of Kasson, Minnesota, and Lyman T. of Roseville, New Jersey. One daughter, Mrs. W. D. Cady of Binghamton, and three sisters, Mrs. John Williams of Farmer, New York, Mrs. George Truman and Mrs. T. I. Chatfield of Owego. His funeral was conducted by Rev. C. M. Bartholomew, Sunday at 2 p. m. at his late residence 338 Front Street. The interment was in Evergreen Cemetery and was private.

Erastus Goodrich, son of Noah Goodrich and Prudence Goodrich was born on 15 Jun 1788 in Glastonbury, Hartford, Connecticut. He died on 29 Jul 1845 in Buffalo, Erie, New York. He married Hope Talcott, daughter of Elizur Talcott Jr. and Dorothy Lord on 27 Feb 1812 in Owego, Tioga, New York.

Hope Talcott, daughter of Elizur Talcott Jr. and Dorothy Lord was born on 10 May 1785 in Glastonbury, Hartford, Connecticut. She died on 13 Feb 1865 in Owego, Tioga, New York. Erastus and Hope were third cousins once removed.

In the early history of the region Erastus Goodrich, who was the son of pioneer Judge Noah Goodrich, was a farmer, brick maker, distiller, lumberman, and rafts man. He was a successful operator and an influential man in the town. He was supervisor of the town of Tioga in 1828, 1841, and 1843, and represented Tioga county in the assembly in 1848. He was the father of George B. and David Goodrich, both of whom were Owego merchants. Three of his sons-in-law, Daniel G. Taylor, George Truman, and Thomas I. Chatfield, were also merchants there. He died June 29, 1854 at Buffalo, while on his return from a visit to his son, Erastus, at DeKalb, Illinois.

Noah Goodrich, son of Ephraim Goodrich and Penelope Tryon was born on 30 Aug 1764 in Hartford, Hartford County, Connecticut. He died on 19 Jul 1834 in Glastonbury, Hartford, Connecticut. He married Prudence Goodrich, daughter of David Goodrich and Sarah Edwards on 23 Nov 1786 in Glastenbury, Connecticut.

Prudence Goodrich, daughter of David Goodrich and Sarah Edwards was born on 14 Apr 1754 in Glastenbury, Connecticut. She died on 30 Jan 1813 in Tioga, New York. Noah and Prudence were second cousins once removed.

Judge Noah and Captain Eliakim Goodrich came from Glastonbury, Conn. in 1799, and purchased from Colonel Pixley 400 acres of land in Owego and Tioga paying therefor \$3 an acre. These pioneers were for years identified with the best history of the towns of Tioga and Owego, as their purchase included lands in both. He was appointed a justice of the peace in 1819 He was elected a justice of the peace in 1827. Via History of Tioga, Chemung, Tompkins, and Schuyler counties, New York, he is said to be buried in the Catlin Cemetery, which is now called Tioga Cemetery, now called Riverside, Judge Noah Goodrich died in 1834, aged ninety years.

When Noah and his first cousin Eliakim, moved to Owego, NY from Gastonbury, CT. (Noah's father Ephraim and Eliakim's father Elisha were brothers) they came with ox-teams and sleds thru the wilderness and purchased a large tract of land nearby where the village of Owego now stands, known to this day as the "Goodrich Settlement." They cleared their land owning all their farming implements in partnership. What was then a dense wooded wilderness is now a beautiful fruitful field. Their principal means for supplying themselves with the necessaries of life was to run rafts down the river to market and walk back.

Noah Goodrich was twice married. His first wife was Prudence Goodrich, daughter of David Goodrich. His second wife was Ruth Goodrich daughter of Jeremiah Goodrich and Hepzibah Edwards. She was born Sept. 5, 1771, and married William Stratton June 11, 1788. Her husband died and she married Asa

Goodrich the son of Elisha Goodrich and Lucy Goodrich. Elisha and Lucy are cousins – grandchildren of Ephraim Goodrich and Sarah Treat. As a died and she was married to Noah Goodrich Oct. 31, 1813. She died Aug. 22, 1846. Even with all the Goodrichs marrying Goodrichs Prudence and Ruth do not appear to be related. Children:

Ephraim Goodrich, son of Ephraim Goodrich and Hannah Steele was born on 09 Dec 1722 in Glastenbury, Hartford, Connecticut. He died on 13 Mar 1771 near Wethersfield, Hartford, Connecticut. Cause of Death: lost at sea. He married Penelope Tryon, daughter of Noah Tryon and Penelope Hollister on 25 Nov 1761 in Glastenbury, Connecticut.

Penelope Tryon, daughter of Noah Tryon and Penelope Hollister was born in 1739 in Glastenbury, Connecticut. She died on 15 Nov 1826 in Tioga, Tioga, New York.

Ephraim Goodrich and Penelope Tyron are second cousins & once removed. Their common ancestor is William Ephrem Goodrich and Sarah Marvin Williams, Great Grandparents.

Penelope Tryon moved from Connecticut with her son Noah and settled in Tioga, New York in 1802, calling the neighborhood by their name, "Goodrich Settlement". There are several families of her children and grandchildren still residing there (as of 1912). She returned to Connecticut several times on horseback, the country she passed through being very thinly settled with white people, but filled with Indians, only an occasional settlement to be found. The house which her son built in Tioga was still standing in 1912.

It reinforced the troops besieging Quebec under Benedict Arnold and David Wooster, and after the retreat from that position on April, 1776, was stationed at Ticonderoga and vicinity, where the men suffered severely from smallpox.

He was Deputy for Glastonbury at the October 1702 session of the General Court. His gravestone states that he left "9 children 43 Grandchildren, and 4 Great- grandchildren."

Son Richard Goodrich married Hannah Bulkeley the granddaughter of Ancestor Gershom Bulkeley. Son William married Rachel Savage. Rachel is the great granddaughter of Thomas Goodrich and Faith Hutchinson. Faith Hutchinson is the daughter of the famous Anne Hutchinson of Boston. John Hollister's mother was Joanna Treat, the aunt of Sarah Treat.

Immigrant Ensign William Ephrem Goodrich, son of John Goodrich and Margarie Howe was born on 13 Feb 1621 in Bury, St James, Suffolk, England. He died in Nov 1676 in Wethersfield, Hartford, Connecticut. He married Sarah Marvin, daughter of Matthew Marvin and Elizabeth Gregory on 04 Oct 1648 in Wethersfield, Hartford, Connecticut.

Sarah Marvin, daughter of Matthew Marvin and Elizabeth Gregory was born on 27 Dec 1631 in Great Bentley, Essex, England. She died on 16 Jan 1702 in Stratford, Fairfield, Connecticut.

William Goodrich first located at Watertown, Massachusetts, and was granted several parcels of land, recorded in the Watertown "Record of Grants and the Possessions of the Lands." He was an orphan and probably came to America at the same time as his brother John and with their mother's brother, William Stillman. In about 1636 many of the Watertown settlers removed to New Haven Colony in Wethersfield, Connecticut, including William Goodrich where he again was assigned several lots. He was among the very first settlers at Wethersfield, being one of a small party known as the adventurers who wintered there before the arrival of the main body. A Naubuc farm "was recorded to Thomas Uffoot in 1641, and by him sold to William Goodrich, in 1646. This earliest homestead, was on the west side of Main Street not far below the site of the present Baptist church. He was made a freeman of Connecticut Colony May 15, 1656. In 1637 Stiles credits William as being one of the 26 soldiers of Wethersfield who took part in the capture of the Indian Fort at Mystic, in the Pequot campaign. Referred by Stiles as "a hero of the Pequot Campaign". William Goodrich was one of the jury which tried Elizabeth Seger on a charge of witchcraft and with breaking also the first and seventh commandments. The jury found "the prisoner Guilty of the inditement in that perticuler" relating only to the seventh commandment. He served as deputy for Wethersfield to the Connecticut General Court, May and October 1660, May 1662, October 1665, and May and October 1666. He was made Ensign of the Wethersfield Train Band, May 1665. The inventory of the estate of Ensign William, taken November 14, 1676, amounted to £915.01.06. Most of the persons bearing the name of Goodrich at the time of the town's incorporation, were the sons of William Goodrich, and in the next generation the sons of Ephraim Goodrich, who married Sarah Treat the daughter of Richard Treat, in 1684. His widow Sarah became the second wife of Captain William Curtis of Stratford. In volume one of History of Ancient Wethersfield by Sherman W Adams and Henry R Stiles, on page 72, Ensign William Goodrich was a veteran of the Pequot War in 1637, serving under Captain John Mason. This would make him 16 or so according to the baptism date.

Sarah Marvin, a daughter of immigrants Matthew and Elizabeth Marvin, was baptized December 27, 1631 at Great Bentley, Essex, England and came to America on the Increase in 1634. She married William Goodrich on October 4, 1648 in Hartford, Connecticut, and they had 5 sons and 4 daughters before William died in 1676. Sarah then married Captain William Curtis in 1677 and died in Stratford, Fairfield, Connecticut. Her will was proved on January 16, 1701/2. Sarah Marvin and William Ephrem Goodrich had the following children:

He is distinguished as having been the defendant and the vanquished party in a lawsuit before the General Court, with the redoubtable (another ancestor of both Donalds and Hutchinsons)

"Sergeant David Goodrich, as he was then known, was, in May, 1704, commissioned by the General Court, Lieutenant of the company of "souldiers raised in the countie of Hartford" for the expedition to march to the relief of Hampshire County, Mass., where the Indians were making trouble for the colonists; and again, in December of the same year, he was dispatched for another campaign. In the campaign of 1709, he served as Captain, Adjutant, and Quartermaster. He served as Captain in the expedition into Hampshire County in February, 1712. On May 12, 1715, he was confirmed Captain of the north company or trainband in Wethersfield. He was appointed one of the "Committee of War" in October, 1723, with full power to act during the "present war," and in May, 1725, was on a similar committee, then bearing the rank of Colonel. "In May, 1723, three companies were sent under command of Major Joseph Talcott, of Hartford, into Hampshire County. One of these, numbering sixty men, was from Wethersfield, and commanded by Captain David Goodrich. In February, 1724, he went north again: this time probably as far as Fort Dummer, near the present Brattleborough, then the only settlement in what is now Vermont. Goodrich remained in Massachusetts most of the time until the close of

the war in December, 1725." (Judge S. W. Adams in Memorial History of Hartford County, II: 467.) (P) In civil, as in military life, Colonel Goodrich was frequently honored. He was Deputy or Representative from his town from 1716 to 1740, at almost every session of the General Assembly during this long period, serving on many important legislative committees. He was several times a member of the Governor's Council, in 1726, and later. During the greater part of his life he was Justice of the Peace, and for many years a Justice of the Quorum. In his town, he was frequently chosen to office, serving as Lister in 1692, Constable in 1695, Collector in 1696, and Selectman in 1702, and in subsequent years. In 1719 he was elected Town Treasurer "to stand until the town see cause to choose another;" and was very many times Moderator of the town meetings. Colonel Goodrich's house stood on the west side of High street, on or near the site of the house erected by his grandson, Captain Elizur Goodrich, about the time of the Revolution, and more recently known as the "Catherine Brigden place. In the original record of the transfer, the grantee is called "David Goodrich, Tailer. (Wethersfield Land Records, III: 253.) He seems to have been a surveyor, or to have had a knowledge of surveying, for he was often employed by the Assembly, with Jonathan Burnham, a grandson of Thomas Burnham, in laying out the bounds of towns and running dividing lines between them. In 1723, he was Captain of a force of 60 men, one of three Companies ordered to proceed to the assistance of the towns of Hampshire County, Massachusetts, against the Indians. He served again as Captain early in 1724, and late in that year is styled "Colonel" in the Colonial Records. After the death of his wife in April, 1698, he married on Dec. 1, 1698, Prudence Churchill, by whom he had twelve children; she died May 9, 1752. (Goodwin's Notes, p. 77; Wethersfield Records, copy at the rooms of the Conn. Hist. His will was dated 14. Apr. 1632, and left, among other bequests, 100 pounds to his younger son William: he had two sons named William. William "the elder" (not our William) was born at Bury St. Edmunds about 1617, buried at Hessett, Suffolk, 17 June 1678, admitted to Caius College, Cambridge, April 1634, aged 17; B.A., 1638, minister at Hessett. His will:

"ffirst and principallie I comend my sowle into the hands of the Almightie God, my Creator, and to Jesus Christ, his onlye sonne, my lord and onlye Saviour, by the merits of whose death and passion I steadfastlie believe to have free p'don and forgivenes of all my synnes, and to be made p'taker of the ioyes of heaven." To Margerie, my wife, my house wherein I now dwell in Bury, and my land in

Horningherth, in the country of Suffolk, for her life, and on her death to descend to my four sons, William Gooderiche the elder, William Gooderiche the younger, John Gooderich, and Jeremy Gooderich. To my son John Gooderich, my house or tenement and lands in Hessett, in the said County of Suffolk, my said wife to have the profits till my son John Gooderich shall attain twenty-one. If he die without lawful issue under twenty-one, then the property to him bequeathed to descend and come to the said William Gooderich the elder, Wm. Gooderich the younger, and Jeremy Gooderich, to be equally divided amongst them. To my said three sons, William Gooderich the elder, William Gooderich the younger, and Jeremy Gooderich, one hundred pounds apiece at twenty-one. If any die under twenty-one and without issue, then the portion or legacy of him or them so dying shall come to the rest of my said sons. My wife to have the managing of the portions during minority, and the increase and benefit arising from their said several portions to be for their education and maintenance, and for binding of any of them forth apprentices, and the residue to be delivered to my sons at the time limited for payment of the portions. If any of my said children prove rebellious, stubborn, and disobedient, and refuse to be maintained, ordered, and governed according to my said wive's discretion, or the discretion of such others as during their minority shall have the managing of their said portions, in case my wife die, then the profits and increase of his or their portions that shall so misdemean shall go to the others of them that are dutiful and obedient. Provided that my wife do pay all such legacies contained in my father's will, which on my part are yet to be paid. To Margaret, daughter of my brother Henry Gooderich, five pounds at 24, with benefit of survivorship. To the two younger children of my sister Susan, by her first husband John Lark, forty shillings apiece at 24, with benefit of survivorship. To the poor of the parish of St. Mary in Bury, forty shillings to be distributed one month after my decease. All the rest of my goods, chattels, wares, stock, plate, household stuff, and moveables to Margerie, my wife, whom I make sole executrix. Thomas Chaplyne, mercer, Clement Chaplyne, brother of said Thomas, Jeremy Stafford, mercer, and my cousin, Robert Gooderich of Bury St. Edmunds, aforesaid supervisors, and for their pains I give to every one forty shillings. If my wife die before the will is fully performed, and have not nominated any person or persons for the pergormance thereof, then my said supervisors to take upon them the performance, and shall also have the managing and employment of all such portions as shall come to any of my said children after the decease of my said wife. Witness: Richard Cooper Harman, by mark; the mark of Robert Brightnall, Philip Crowe." (P) From the "Parish Register," of St. Mary, Bury St. Edmunds: "BURIAL --- April 21, 1632, John Goderich, Clothyer."

William Goodrich is the earliest ancestor to whom this family can be traced. The marriage of a William Goodrich and Margaret Richardson in Felsham in 1568 is given in the Suffolk Marriage Index at Ipswich. This is probably the marriage of William Goodrich of Hessett. It must be from a transcript as the earliest extant register of Felsham begins in 1656. It is stated that William was the son of an Adam Goodrich of Felsham whose will is dated, 1596-97. Other records are stated to exist which, if substantiated, would give William the pedigree, *Adam, Robert, John, Robert* but the documents are not quoted and have not been found again. That the two immigrants, John and William Goodrich, who settled in Wethersfield, Conn., descended from William of Hessett is amply proven by documents preserved in the Archives of Connecticut. Their brother, Rev. William Goodrich, dying in 1678, left property to the sons of John and William, and, in order to establish the claim of the heirs certain documents had to be filed in court. Part of the evidence is printed in Manwaring's Hartford Probate, including the will of Rev. William Goodrich of "Hegesset." The records of Hessett were searched, in a somewhat sketchy fashion, years ago and the results embodied in the Goodrich Genealogy. In 1938, much more exhaustive work was done. [Footnote: By W.L.Holman, S.B., for C.D.Stillman, Esq.] This account is based on that research and some additional work. It seems quite evident, to the present compiler, that John Goodrich was the eldest son of William. He may have been born in Felsham, if his mother belonged in that parish. In the lapse of so much of specific data, conclusions have to be based on the customs of the time, the laws, etc., as well as from such vital records as may be unearthed. Hessett is suggested to have been originally a part of Rougham, by Canon Cooke, in his admirable history of this parish. He states that it was probably called "Hegesset" earlier and was held by the Abbot of Bury until the dissolution of the monasteries, in 1541, when it was conveyed to Thomas Bacon. The Bacon family held the property until 1653, when Lionel Bacon who had possession, died without male issue. It then passed to Robert Walpole, grandson of Lionel's eldest sister, Elizabeth, who was father of the famous Sir Robert Walpole. In 1724, the manor was sold to Thomas le Heup. The beautiful parish church of Hessett, erected in 1472, was dedicated to St. Ethelbert, King and Martyr, and became a rectory in the Deanery of Thedwastre, Archdeanery of Sudbury.

Henry Goodricke, of Wisbech, Isle of Ely, First ancestor of the Yorkshire branch of the Goodrick family, was second son of William Goodryke of East Kirkby, and brother to Thomas Goodryke, Bishop

of Ely and Lord Chancellor of England in the reign of Edward VI. In 1542 he purchased the Manor of Ribston and other lands in Co. York of Charles Brandon, Duke of Suffolk, and by letters patent, dated August 28th, 1545, King Henry VIII. granted to him the Manor and Rectory Church of Hunsingore, Co. York, with their rights. In the late Priory or Hospital of St, John of Jerusalem, the advowson and rights of patronage of the Church of Hunsingore and Walshford. Henry also bought Kippax Hall and Park, Co York, from Basse Gascoigne, who was related to his first wife and in his service. Henry also possessed land and property at Doddington Wisbeach and Ely, also at Newport in Co. Essex, and in Aldermanbury in the City of London. The will of Henry was proved by his eldest surviving son Richard. It is a very long document, and deals exhaustively with the whole of his estate. After bequeathing several legacies and annuities to his servents and relatives of whom I will, however, only mention, in addition to his sons William, Richard, Christopher, and John his sister Fulnetby, his daughter Alborough and her husband Christopher Langholme, and his nephews Lionel and Thomas Goodrick. Henry appoints his brother Thomas (Bishop of Ely) supervisor of his will in the following words:- " I will that my burial black Coats and gowns be given to all my old servants before rehearsed and to other my waiting servants as my Executors shall think me true and convenient with that advice of my lord of Ely whom I ordain and make the supervisor of this my testament and last will charging and commanding all my children to be ruled and ordered by his advice and council. And I beseech his Lordship as one brother may do for an other to be good lord unto them." Bishop Goodryke however pre-deceased him. William, the eldest son, died in his fathers lifetime, and Richard Goodrick, the second son, therefore proved this will, and succeeded to the Ribston estate (1556). Christopher, the third son, who should have succeeded to his father's lands at Kippax and Wisbech, died without issue, and was dead in 1563\4, so that this property fell to John the fourth son, who resided at Dodington, and married Margaret Eston. According to "Flowers Visitation," 1564, Richard Goodricke was "heir by order of Law, by a covenant made by his father to the said Richard his son," which indicates the probability of a separate deed having been made confirmatory of the testamentary settlement of his estate made by Henry Goodricke.

This office he continued to hold during the reign of Lady Jane Grey (July 1553); but he made his peace with Queen Mary, conformed to the restored Catholic religion, and, though deprived of the Chancellorship, was allowed to keep his Bishopric until his death on 10 May 1554 at the Bishops Palace, Somersham, Co Cambridge and buried Ely Cathedral.
