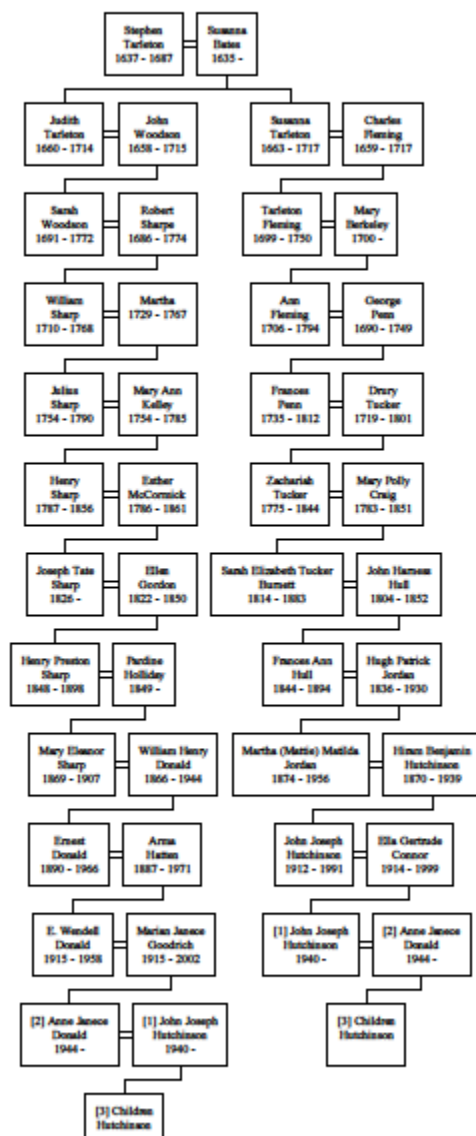


## Tarleton to Hutchinson

### *Direct Descendants of Stephen Tarleton*



This is the story of the closest common ancestors to the children of John Joseph Hutchinson and Anne Janece Donald. This branch of the family got off to a bad beginning with the escapades of Stephen Tarleton. Because these stories are derived from many sources the names and dates are not totally consistent but there are multiple sources for each link.

## *Generation 1*

### **Stephen Tarleton and Susanna Bates**

**Stephen Tarleton**, born 1637 in New Kent, Virginia; died 1687 in St. Peters Parish, New Kent, Virginia. He was the son of John Tarleton and Ursula Fleming. He married **Susanna Bates**. Susanna Bates was born September 30, 1635 in York, Virginia; died in Virginia. She was the daughter of John Bates and Elizabeth Winston.

Stephen and Susanna are the great<sup>9</sup> grandparents of the Hutchinson children through the Hutchinson line and great<sup>10</sup> grandparents through the Donald line. Sisters Judith Tarleton and Susanna Tarleton married ancestors John Woodson and Charles Fleming.

Stephen Tarleton was the son of **John Tarleton** (1610-1633) and **Ursula Fleming** (1610-1680). Susanna Bates was born September 30, 1635 in Virginia and died there in 1655. She was the daughter of **John Bates** (1598-1666) and **Elizabeth Winston** (1605-1701). There is some confusion on the birth date of Ursula Fleming that calls into question the identity of Stephen's mother. There are inconsistent birth days of children and Susanna's death in 1655 is in question.

Stephen Tarleton's name appears in the records of York County, Virginia beginning in 1659. His occupation was shown as a tobacco appraiser. On April 12, 1660, he was charged by a servant girl, Mary Gunnell, who deposed that "Stephen Torlington[sic] got her with child and did use her several times by day and also by night in her master's hall and also in other places." It was shortly after this case that he removed to New Kent County. In 1663, he patented 394 acres of land in that county. This tract was located on the north side of the main branch of Blackwater Creek, and a fork of the Chickahominy Swamp, south of the Pamunkey River. In 1676, he was active in the "Bacon's Rebellion" with Nathaniel Bacon, and he later renounced this association in a letter to His Majesty's Commissioners in Virginia pleading for pardon. However, a year later, in 1677, he was again involved in rebellious activities when he signed "The Blisland Parish Grievances," a list of complaints about the acts of oppression committed by the crown's agents in the Virginia Colony. In May, 1682, he was arrested by the Sheriff of York County for inciting the "Tobacco Riots", during which tobacco plants, crops, and stored stockpiles were destroyed by the planters rather than sell them to the crown's buyers. This uprising was the last of its kind until the events which led to the American Revolution.

Letter to Honorable Herbert Jeffries, Sir John Berry, and Francis Morrison, his Majesty's Commissioner's in Virginia:

"The humble petition of Stephen Tarleton of New Kent county most humbly sheweth that your petitioner as he most penitently and sorrowfully acknowledgeth seduced into the late horrible Rebellion, and taken yet unlawful oath imposed by the late grand Rebell Nathaniel Bacon, Jr. and being conscious of his guilt thereof did upon the firste publishing his most sacred Majesty's gracious and surpassing Act of pardon, to his distressed subjects of this late disloyall Colony lay hold of the same, and take the oath of allegiance and then was and still is ready to performe those other due and reasonable conditions which by his Majesty's said pardon he is justly enjoyed to doe and being by the Honorable Governor's proclamation of the 9th of February last referred to the determination of your honor your petitioner in all humility beseech the mercy and pardon for his said crimes, and humbly prayeth yet he may be admitted to the full benefit of his Majesty's said Act of pardon."

## *Generation 2*

### **John "The Merchant" Woodson and Judith Tarleton**

**John "The Merchant" Woodson**, born 1658 in Curles, Henrico, Virginia; died December 5, 1715 in Henrico, Virginia. He was the son of **Lt. Col. Robert Woodson** and **Elizabeth Ferris**. He married **Judith Tarleton**. **Judith Tarleton**, born 1660 in New Kent, Virginia; died 1714 in Henrico, Virginia. She was the daughter of **Stephen Tarleton** and **Susanna Bates**.

John Woodson was a Quaker. He lived at Curles in Henrico County, Virginia. He was employed as a carpenter 1684-1691 and merchant from 1702 onward. On October 21, 1687, Robert Woodson Sr. (John's father), John Woodson Sr., William Lewis, and Thomas Charles were granted 470 acres of land in Henrico County in the Parish of Verina and on the north side of James River, beginning, & continuing standing on the western branch of the Deep Run.

John Woodson was appointed constable in room of, and by nomination of Mr. Charles Blanchrville on February 1, 1687.

John Woodson, Sr. Carpenter, of Henrico Parish & Count, (and Judith his wife) to William Randolph of aforesaid County & Parish, Gent. In consideration of a proportionable part of ye rights, Survey & other charges in taking up & Patenting 1850 acres upon Chickahominy Swamp in same Parish & County, conveys to said Randolph, 400 acres, being a part & dividend of above said tract, beginning at ye side of said Swamp a little above ye house where John Morton now lives (being a quarter built by and belonging to said Randolph: Judith, wife of John Woodson, relinquishes right of dower &c. Recorded April 1, 1689.

There are dozens of other land transactions recorded during this time. Most are routine. The most interesting aspect is that in many cases tobacco was used as a currency.

**Will of John Woodson, of Henrico Co.**

To son Tarlton Woodson, tract commonly called Neck of Land & Swamp, also about 1000 acres in Henrico County at Dover on North side James River beginning at the upper line of Charles Fleming & bounded up the River to John Pleasants land near the Mouth of Beaver Dam Creek & so out into the woods & so on the back lines to come opposite to the Lower line of the said Fleming thence to the said Flemings Corner Iver(?) & so long his back line & upper line to the place began.

To son Jacob Woodson, tract of land at Dover lying in Henrico Co., beginning at Samuel Birk's lower line thence down ye River to the Lower Side of the mouth of Janitoe Creek thence into the Woods to the head line of that Survey, binding on my old Survey, & then up the back lines up the River ward till it comes to his Brother Tarlton's corner line thence on that line & the lower line of Samuel Birk to the place began.

To son John Woodson, tract of land beginning at Jacob's lower line below the mouth of Janitoe Creek thence down the River Ten pole the mouth of Mill Creek thence on a Strait line to the house of William Hodges up the hill thence on a strait course into the woods to strike the Back lines of my first patented Land one hundred and twenty Pole below where the said line Crosses the mill Creek thence on the back lines, Except 100 acres which I give to Josiah Paine son of George Paine & Mary Paine to be laid out below Mill Creek & to bind on the said back line to him the said Josiah Paine. My will is that my son John's Bounds shall continue from the said Creek upwards on the said Back lines to his Brother Jacob's lower line, thence on that line, to the River & place began including my Corn Mill & all that part of Sabot Island which lies opposite to the said tract bounded by a straight line Ten pole below the Island & so crossing the Island To strike the main River forty pole below the house of John Prier.

To son Robert Woodson, tract of land beginning at his Brother John's lower line at the River thence down the River 50 Pole below the mouth of Stony Creek thence on a strait line at right angles from the River 600 yards out then on a strait line to strike my back line fifty pole below where the said line crosses Stony Creek , then on the said back line to his Brother John's Lower line near where I have given Josiah Paine a hundred acres so to bind on his Brother John's lower line so to the River including my Sawmill & appurtenances, & that part of Sabot Island which reaches from his Brother John's line in the said Island till it comes 50 poles below the mouth of Stony Creek & from thence a strait line to be run to the South or main River.

To son Josiah, tract of land beginning at his Brother Robert's lower line thence down the river to the mouth of a Gully below where John Maxfield now dwells thence into the Woods at right angles from the River to be back line thence on the said line to his Brother Robert's lower line thence on that line to the place began thence over the little River binding on his Brother Robert's lower line in Sabot Island to the main South River thence down the said River till it comes opposite a Gully near where John Maxfield now dwells.

To son Stephen, tract of land beginning at his brother Josiah's lower line thence down the River

to John Huckaby's then out into the Woods at right angles from the River to be back line on that line to his Brother Josiah's lower line, thence on that line to the place began, also the remainder of Sabot Island from Josiah's lower line to the lower end of the said Island both land & Island unto him ye said son Stephen & his heirs forever.

To daughter Judith, tract of Land on James River beginning at her Brother Stephen's lower line on the River thence down the river half a mile thence into the Woods at right angles from the River to ye back line of the land Surveyed by William Womack thence on that line till it comes opposite with her brother Stephen's lower line, thence on that line to the River & place began. To daughter Elizabeth, tract of land beginning at her sister Judith's lower line thence down the River half a mile thence at right angles from ye River to the back line of the land Surveyed by William Womack thence on that line to her Sister's lower line thence on that line to ye River & place began.

To son Jacob Woodson, tract of land opposite elk Island where Joshua Stephens now or of late lived containing by Patent 348 acres.

To sons Josiah & Stephen, land at Half Sink on Chickahominy Swamp, Henrico County except 150 acres to be bounded on the line of John Pirant & the Swamp all the rest my said sons to be equally divided, Josiah to have the upper part & Stephen the lower part.

To son Tarleton one quarter part of Elk Island.

To son John one quarter part of Elk Island.

To son Robert one quarter part of Elk Island.

To son Jacob the other quarter part of Elk Island, to be laid out opposite to his land where Joshua Stephens now or of late did dwell.

To son John my young negro Dick.

To son Robert negro Winter.

To son Jacob negro girl Bess & her increase.

To daughter Judith negro girl Judy & her increase.

My negro Old Dick to fall to him of my four sons Tarlton, John, Robert, or Jacob that will give the most for him & the product to be equally divided among my 8 children.

Executors to confirm to Thomas Harwood 150 acres of land at half sink bounded on Pirant's line & the Swamp provided he shall pay 3400 pounds of tobacco.

Son Tarlton shall confirm unto my (the testator) Brother Benjamin Woodson the land he (now) lives on at Chickohominy Swamp.

Son Tarlton shall confirm to John Canon, son of William Canon & Judith his wife, 100 acres up James River, likewise 100 acres to William Cannon provided he pays to my Executors ?10 Courtrey(?) pay, and to confirm to Charles Huddesey 100 acres for which I have received payment & 100 more if the said Huddesey pays 80 bushels of wheat & brings it to Dover Mill. Executors to confirm to Edward Lester a dividend of Land up Mill Creek which I formerly bargained for.

Executors to confirm to Henry Lester 200 acres up Mill Creek provided he pays them ?20 currency, also to confirm to Robert Hughes three hundred acres of land being part of five hundred for which I have Charles Fleming 's bond for the remaining 200 to John Jones of Manakin Town.

Executors to confirm 100 acres to William Thornell lying between Robert Adams & the line of Richard Woodson provided he shall pay ?10 ready money.

If any one or more of my children should dye without heirs or before they arrive to the age of 21 years, then his or her or their estate shall be equally divided among the survivors & the heirs of such if dead as have arrived to the age of 21 years or have had lawful heirs, before they arrive to that age to be equally divided. Real estate not heretofore given to my executors.

Executors: Sons Tarlton Woodson, John Woodson, Robert Woodson, & Jacob Woodsn.

Dated November 25, 1715.

Witnesses: James Cocke, Arthur A. M. Markham, Edward East (Bertha Newcome), Mathew M. Dod.

Proved Dec. 5, 1715.

An inventory of the estate of John Woodson, deceased taken and appraised this 23d of April 1716 by us Richard Cocke, Thomas Randolph & John Archer three of the appraisers appointed by an Order of Henrico Court dated ye 5th day of Dec. 1715, as followeth.

### **Charles Fleming and Susanna Tarleton**

**Charles Fleming**, born December 10, 1659 in Scotland; died October 7, 1717 in Flemings Park, Henrico County, Virginia. He was the son of **John Fleming** and **Mercy Mary Randolph**. He married **Susanna Tarleton** 1680 in New Kent, Virginia. **Susanna Tarleton**, born 1663 in St. Peters Parish, York County, Virginia; died July 10, 1717 in New Kent, Virginia. She was the daughter of **Stephen Tarleton** and **Susanna Bates**.

Colonel Charles Fleming resided at New Kent County, Virginia and in Charles Parish, York County, Virginia. Susanna Tarleton resided at St. Peters Parish, New Kent County, Virginia. She died July 10, 1717 in New Kent.

Known children of Charles Fleming and Susanna Tarleton all born in St. Peters, New Kent County, Virginia are:

1. Susanna Fleming, born 1680 in St Peters Parish, New Kent, Virginia; died November 15, 1757 in Goochland, Virginia; married John Bates February 10, 1713 in Home Charles Fleming, Henrico, Virginia; born March 10, 1684 in York County, Virginia; died March 12, 1742 in York County, Virginia.

3. Elizabeth Fleming born October 23, 1687 in St Peters Parish, New Kent, Virginia, ., died July 20, 1758 in Amelia, Virginia, married Col. Samuel Jordan. According to Quaker records, he was married in December 1703 to Elizabeth Fleming, daughter of Charles and Sussanna Tarleton Fleming of New Kent County. Charles Fleming was the son of Sir Thomas Fleming and grandson of Lord John Fleming, Earl of Wigton, Scotland. Although Samuel and Elizabeth were married according to Quaker rites, they later became Episcopalians.
4. Ursula Fleming born 1683 in New Kent, Virginia, died 1760 in Chesterfield, Virginia, married Tarleton Woodson August 3, 1710. Ursula Fleming and Tarleton Woodson are cousins. Their mothers, Susanna Tarleton and Judith Tarleton are sister, the daughters of Stephen Tarleton and Susannah Bates.
5. Grace Fleming, born 1686 in New Kent, Virginia; died February 10, 1711 in Henrico, Virginia; married George Bates; born November 18, 1677 in St Peters, New Kent, Virginia; died 1719 in York County, Virginia.
6. Judith Fleming born November 1689 in Goochland, Virginia, died 1743 in New Kent, Virginia, married Thomas Randolph.
7. **Tarleton Fleming**, born December 12, 1699 in St Peters Parish, New Kent, Virginia; died

December 18, 1750 in Rock Castle, Goochland, Virginia; married (1) Hannah Bates; married (2) **Mary Berkeley** 1717 in Virginia.

8. Ann Fleming born 1705 in New Kent, Virginia, died 1778 in Goochland, Virginia, married Josias Payne, son of George Payne and Mary Woodson, 1732.
9. Caroline Fleming was born in Henrico, Virginia.

Charles Fleming was born perhaps in Glasgow or Cumbernauld, Lanarkshire, Scotland, and came by 1653 with his parents to America. He and his wife were living October 7, 1717; but he was dead by December 1720, when his executor to his will, John Fleming, was mentioned. His will is gone. He married about 1684, Susanna Tarleton. She was the daughter of Stephen Tarleton who died in 1687. He resided in New Kent County, just south of York River. He was a merchant and planter, owning slaves and extensive tracts of land in New Kent, King William, Henrico and what is now Goochland Counties. The family were Quakers.

He married **Sarah Woodson**. **Sarah Woodson**, born 1691 in Varina, Henrico, Virginia; died 1772 in Virginia. She was the daughter of **John The Merchant Woodson** and **Judith Tarleton**. Tarleton Fleming married his second cousin Hannah Bates before he married Mary Berkeley. Tarleton and Hannah have the same great grand parents John Bates and Elizabeth Winston.

Robert Sharp undoubtedly had other children not mentioned in the will, either because they had pre-deceased him, or because he had already given them their portion, or for some other reason. An article from the 30 March 1769 "Virginia Gazette" mentions that in that year Robert Sharp was 83 years old and had "156 descendants all now alive."



Other possible children of Robert Sharp, Sr. These children died before Robert Sharp, Sr.'s death and were not mentioned in his will.

Mary, of New Kent Co., Virginia, married George Martin.

Isaac, died before 1756.

John, died Albemarle County after 1759.

Josiah, died before June 1751.

She was the daughter of **Edmund Berkeley** and **Judith Randolph**.

#### *Generation 4*

**William Sharp**, born 1710 in Henrico, Virginia; died April 1768 in Dale Parish, Henrico, Virginia. He was the son of **Robert Sharpe** and **Sarah Woodson**. He married **Martha** who was born 1729; died June 1767 in Chesterfield, Virginia.

William died before his father's will was recorded. It was mentioned that William was a blacksmith when he sold land on Four Mile Creek to John Pleasants. Henrico County later became Chesterfield County. He owned land in Dale Parish. Described as William Sharpe of Dale Parish when he sold land to Thomas Tanner.

**George Penn**, born 1690 in King Queen, Virginia; died September 1749 in Caroline, Virginia. He was the son of **John Penn** and **Lucy Granville**. He married **Ann Fleming** 1734 in Caroline, Virginia. **Ann Fleming**, born 1706 in Jamestown, James, Virginia; died 1794 in Amherst, Virginia. She was the daughter of **Tarleton Fleming** and **Mary Berkeley**.

George Penn's and Ann Fleming's nephew John Penn 1741 was one of the signers of the Declaration of Independence. John was the son of Moses Penn 1712, George's brother and son of John Penn and Lucy Granville. George was also married to Ann Madison. Children:

  6. Lt. Col. William Penn born April 7, 1745 in Drysdale Parish, Caroline, Virginia – died June 17, 1777 in Amherst County, Virginia – married Martha Smith.
  7. Moses Penn born January 13, 1747-1748 Drysdale Parish, Caroline, Virginia; died October 10, 1774 in Norfolk, Virginia – cousin of John Penn 1741 – grandson of John Penn 1650 – nephew of Moses Penn 1712.

John Penn was born on May 17, 1741 in Caroline County, Virginia. He was a "transplanted" patriot, as he would build his political and legal career in North Carolina. He was the only child of Moses Penn a moderately successful plantation owner and his (ex-wife at the time), Catherine Taylor. Penn received little formal education, although his parents could well afford to pay the expense of his tuition. At the age of eighteen, upon the death of his father, he had only been instructed for a few years at a country school and was largely self-educated. At that time, he was urged to study law by his mentor, Edmund Pendleton. Pendleton maintained a vast law library, which he put at Penn's disposal. Penn studied hungrily and remarkably passed the bar examination at Virginia at the age of twenty-one.

Penn was, however, unable to forge a rewarding practice in Virginia so he moved with his wife, Susannah Lyme, and their three children to Williamsboro, North Carolina. There, he displayed great ability and eloquence, and his practice flourished, as did his interest in politics. He soon became a leader in his community. He was elected to the provincial legislature in 1775 and to the Second Continental congress, taking his seat on October 12, filling a vacancy. It was said that Penn, though very talkative in private, rarely spoke in congress. However, he was very diligent in public business and voted consistently for independence.

After signing the Declaration, John Penn returned home and was chosen at once to occupy an important position on the North Carolina board of war. His major task was to keep the militia well supplied. His dedicated efforts in fact helped the Americans force Lord Cornwallis into retreat before the end of 1780. In March of 1784, he was appointed receiver of taxes for North Carolina, but he resigned that office the following April. His reason for doing so was the fact that the state, while eagerly maintaining the cause of independence by resolutions and declaration, refused to furnish the means by which it could be secured.

John Penn afterward resumed his life as a private citizen due to the state of his health, and continued to practice law. He died on September 14, 1788 at the age of forty-eight.

On April 5, 1783 in Cumberland County, Virginia an order by the officer of the poor requires Mary Sharp to put her son, Julius, into an apprentice position. This suggests the boy is an orphan with no father. He was living with his stepmother and sister Elizabeth and brother Isaac. He appears on a petition next to George Kelley.

There was only one Julius Sharp enumerated on all of the 1787 tax lists of Virginia. He was in Henrico Count. He would seem to be the only Julius Sharp to be considered as the father of the young Rockbridge County, Virginia, Sharps. All 5 columns of the tax list were blank for Julius, showing that he owned no personal property and that he had no sons between the ages of 16 and 20. This would indicate that Julius was either an old man or that if he had sons, they were born after 1771. The latter is the case.

Julius Sharp served as a Private in Captain William Mosby's Co., 5th Virginia Regiment of Foot, commanded by Lt. Col. Josiah Parker. On a Muster Roll from August 1776 to May 31, 1777. Discharged January 1777.

I am Dear Father your Affectionate Son, Wm. Tucker. Witnessed by Gabriel Penn and Aaron Campbell (by his mark).

Addressed to Mr. Drury Tucker, Amherst. At a Court held for Amherst County the fifth Day of July 1790 On the Motion of Drury Tucker this Instrument of Writing being proved by Gabriel Penn a Witness thereto is admitted to Record. William Tucker is a son by Susannah Douglas.
